Anderson County Fiscal Court Meeting – February 3, 2026

### Activity Report

January 22, 2026

- Attended NWS conference call at Anderson Board of Education and winter storm preparations.

January 23, 2026

- Shelters are secured at Anderson County Middle School, Anderson County Health Department and the Anderson County Community Building.
- Attended the KyEM conference call and 2<sup>nd</sup> NWS conference call.
- Picked up 50 cots from the Methodist Church (on loan) and took to the ACHD with assistance from the ACFPD.

January 24, 2026

- Secured 180 more cots with bed kits and hygiene kits from Jessamine County EMA (to keep) with assistance from the City of Lawrenceburg Fire Department.
- Secured 2 pallets of bottled water and 2 pallets of MRE's from KyEM with the assistance of the ACFPD.
- Deputy Womack opened the EOC at ACEMS.
- Winter storm is coming tonight. Monitoring weather radars and power outage maps.

January 25, 2026

- Continuing monitoring weather radars and power outage maps.
- Request made by a local citizen for kerosine. Secured (5) 5-gallon cans and with the assistance of the ACFPD was able to deliver 5 gallons to them.
- Many requests from local citizens for transportation assistance to get to work. KyEM filling those request for essential personnel.

January 26, 2026

- Still at EOC monitoring power outage maps and in constant contact with local and state officials on any unmet needs and updates to current situation.

January 27, 2026

- Delivering groceries to a local citizen on Jenny Lillard Road.

January 28, 2026

- Jimmy Robinson and I assisted a resident on Ninevah Road with propane issue.
- Still monitoring power outage maps and shelters still on standby.

January 30, 2026

- Jimmy Robinson and I responded to Birdie Road for a resident requesting aid in getting to town to pick up groceries and an electric heater. I spoke with resident and took her to Walmart and then back home.
- Responded to possible CO leak on Blackberry Drive with the ACFPD.

January 31, 2026

- Secured an electric heater for a citizen on Eagle Drive due to central heat and air not working. Already has a couple for her duplex but with extreme cold temperatures but could use one more.

February 1, 2026

- Possible gas leak on Gailane Street.

February 2, 2026

- Responded to CO leak at resident's house on Jenny Lillard Road with ACFPD.

February 3, 2026

- Attended the Court Meeting.

## ACEMS

### Department Head Report – February 3, 2026

- **Total EMS Runs for January:** 363

- **Winter Storm Response:**

We would like to formally recognize the following individuals for their exceptional hard work, dedication, and extended hours during the recent winter storm event: EMT's Trevor Sams, Bryce Flach, Steven Meyer and Will Samuelson, Lieutenant David Chisholm, Captain Chelsea Norris, Major's Sue Johnson, Tyler Perraut, and Chris Hood, and Deputy Director Amy Womack. Their commitment ensured uninterrupted EMS coverage for Anderson County during hazardous and difficult conditions.

During this storm event, the agency experienced the loss of one EMT who declined to report for duty due to personal safety concerns related to compensation. The employee stated, "*I'm not risking my life for \$13 an hour, that's insane.*" This highlights the continued challenges EMS agencies face with recruitment, retention, and competitive compensation during high-risk operational periods.

- **Employee Recognition:**

We would like to recognize EMTs Bryce Flach and Shelby White for the exceptional job they performed on a recent call. The family expressed their appreciation for the professionalism, compassionate care, and respectful manner shown to their mother during the response. Their actions reflect positively on the department and exemplify the level of service we strive to provide to our community.

- **Staffing Updates:**

The department has hired an additional part-time EMT and a part-time paramedic with many years of experience to assist with ongoing staffing needs and service delivery.
